2. Authors and Authors responsibilities

-No publication charges for the articles submitted by the Life member of the society (Society for Minor Fruits, Medicinal and Aromatic Plants, owner of the journal). Individual Life membership fee of the society / journal is 100 US Dollars. No publication charges for invited articles. For Non-members of the society, an amount of 10 US Dollars for Article Submission Charge + 30 US Dollars for Article Publication Charge, total 40 US Dollars is to be required per article.

- Authors are obliged to participate in peer review process. Authors may suggest at the most three potential referees for their manuscript. However while suggesting referees, utmost care should be taken to not to seek experts who are likely to be more sympathetic to the authors' findings. The e-mail address of the referee must be registered on his/her organization domain. The final decision of extending invitation to the suggested referee for reviewing the submitted manuscript will rest with the Chief Editor/ Editorial Board.

- All authors have significantly contributed to the research. Authorship should be confined to those who had noteworthy involvement in the conception, design, implementation and analysis & interpretation of the reported study. All those who have made substantial contributions should be listed as co-authors, while others, who have made contribution in certain utilitarian parts of the reported study, should be acknowledged. It would be the binding on the corresponding author to ensure that only suitable co-authors are included in the paper and that all co-authors have gone through and agreed upon the final version of the paper for its submission for publication.

- In order to foster transparency, authors are encouraged to tender an author statement highlighting their individual contributions to the reported study using the pertinent CRediT (Contributor Roles Taxonomy) roles: Conceptualization; Data curation; Formal analysis; Funding acquisition; Investigation; Methodology; Project administration; Resources; Software; Supervision; Validation; Visualization; Roles/Writing - original draft; Writing - review & editing.

- All authors are obliged to provide retractions or corrections of mistakes as per comments or suggestion of referee.

- List of references must be mentioned. All authors must reveal any financial and personal relationships (if any) with other people or organizations, which could prejudice the findings of the reported study.

- Forbidden to publish same research in more than one journal. Submission of a manuscript suggests that neither the reported study has been published earlier (except in the form of an abstract, a published lecture or academic thesis) nor it is under consideration for potential publication elsewhere.

3. Peer-review process

Each paper in every issue will be reviewed (Peer Review) by concerned field of experts. The policy is **double blind review**. The list of referees is published in concerned issue of the journal in the last part of the journal in such a way that author of a paper or referee or *vice-versa* cannot identify each other. Referees are advised to inform the Chief Editor about any potential conflict of interest as soon as he/she receives the invitation to review the manuscript. Further, their judgments should be objective and be treated confidentially. Referees should point out to authors any relevant published work which is not yet cited.

4. Publication ethics

It is mandatory to submit a statement by the first author or corresponding co-author that **"The**

manuscript is the original work of author or all authors that has not been submitted for publication to any other journals. In addition, the author/s declares that they have no conflict of interest.

The Chief Editor / Editorial board assumes no responsibility for the statements, opinion or facts expressed in the journal, which vests entirely with the author(s) thereof. It is understood that the author (s) have obtained a prior approval of their Department, Faculty or Institute where such approval is necessary.

Under the circumstance, where the Chief Editor / any member of Editorial board is come to know that the paper is false, copied from others or already been published by the same author or authors, the paper selected for the issue will be withdrawn. Even it come to knowledge after publication of the paper, Board has right to take legal step if necessary. The board is agreed to allow correction, clarification, retractions and apologies when needed. The author or authors are advised to follow the following format of the journal (guide line to the author) when authors begin preparing their manuscript for submission.

The International Journal of Minor Fruits, Medicinal and Aromatic Plants (IJMFMA) publishes critical reviews, research papers and short communications. The manuscript should preferably pertain to the research works carried out during last five years.

Review / strategy paper: It should be comprehensive, up-to-date on a recent topic of importance. It should have a specific **Title** followed by the **Name (s) of the author(s), Affiliation, Abstract, Key words**, main text and **References**.

Research paper: A research paper has the following characteristics:

Title: It should be bold and in running form. Use the font Times New Roman (14 point). Botanical and scientific names should be italicized. Author name (s) should be in running and bold with full address of **the first author including email address**. The address of other author(s) if different from the first author should be given as footnotes and indicated by consecutive superscript numbers.

Abstract: The abstract should not exceed 250 words. It should be suitable for indexing and publication in abstracting journal.

Key words: Pertinent key words may be given.

Text: The text should be typed in double space on one side with 3 cm margin on all sides. Use the font Times New Roman (12 point). The text should have Introduction, Materials and methods, Results and discussion, Acknowledgements (if any) and References. Units and abbreviations should be in metric (SI) system. The length of the paper should not exceed 3000 words.

References: The References should be listed alphabetically by the author's last names. In the text References should be cited in the text (by parenthesis) by the author (s) name(s) and year; in the form of (Anon., 1990); (Mandal, 2012); (Rai and Dwivedi 1992); (Pandey *et al.*, 2013). References at the end of the text should be given in the following form:

The manuscript should be in paragraphs mentioning the introduction of relevance of the work, followed by a short description of the materials and methods employed, results and discussion and conclusion.

Acknowledgement: The author/s must provide clear acknowledgement in the paper about fund or any kind of support received during course of study of submitted research paper.

5. Copyright and Access

The copyright of the individual article retains with the author or authors of the concerned article, who will also enjoy the right to publish the 'Version of Record' of their article. However, author/authors will allow the publisher to publish the article in the International Journal of Minor Fruits, Medicinal and Aromatic Plants and in no case shall restrict the Publishers to enter into license agreement with the third parties for improving the visibility of published work amongst the academic community and beyond.

The author or authors will be informed by the Chief Editor after publication of paper and also URL to be informed so that they can access their paper. The electronic versions of published issues are accessible from the journals' website and are available to the readers free of cost.
